### PRACTICE INCENTIVE PAYMENT (PIP):

- Tier 1 payment after GPMP, TCA or MHTP- plus review x 1. If GPMP, TCA or /MHTP already in place Tier 1 payment after reviews x 2.
- Tier 2 payment after minimum of 5 eligible MBS services which can include Tier 1 services.
